CONSTITUTIONAL LAW – SIXTH AMENDMENT OF THE UNITED STATES CONSTITUTION – ARTICLE 21 OF THE MARYLAND DECLARATION OF RIGHTS – RIGHT OF ACCUSED TO CONFRONT WITNESSES – FORENSIC EVIDENCE – The Confrontation Clause of the Sixth Amendment to the United States Constitution provides a criminal defendant with the right "to be confronted with the witnesses against him." Article 21 of the Maryland Declaration of Rights similarly provides that, "[i]n all criminal prosecutions, every man hath a right … to be confronted with the witnesses against him; … [and] to examine the witnesses for and against him on oath." In *Williams v. Illinois*, 567 U.S. 50 (2012), the Supreme Court considered whether a laboratory report containing the results of DNA analysis was "testimonial" within the meaning of *Crawford v. Washington*, 541 U.S. 36 (2004). *Williams* resulted in a fractured decision, revealing that there was not a majority position on the Supreme Court concerning the minimum requirements for a forensic test report to qualify as testimonial for purposes of the Sixth Amendment.

Use Multi-factor Authentication



Protect your data, in storage and in transit



Create Backups

Strategy can be as simple as



Use Multi-Factor Authentication on all services





Encrypt data when sharing or moving



Multi-Factor Authentication

Protect against creden tial theft

Protection from phishing Block 99.9% of account hacks

Becoming industry standard

Multi-Factor Authenticator – Not SMS

- Forms of authentication:
 - + Something you know password
 - + Something you are biometric
 - + Something you have security token
- Use and MFA app like Authy or MS Authenticator instead of SMS based authentication
- Use on multiple devices and back up authentication links
- Also known as 2-Factor, 2FA, 2-Step Verification



Protect data on device

Practical tips:

- Create a separate administrator account on your computer
- Set yourself up as a user and don't use the administrator account
- Minimizes installation of accidental or unneeded software
- Lock device when stepping away
- Encrypt data on external hard drives and flash drives with BitLocker

Protect data on device -

Bitlocker

Bitlocker is built into Windows - whole disk encryption

Turn on Bitlocker

- 1. Start > Manage Bitlocker > Open
- 2. Turn on Bitlocker
- 3. Save to a file (on USB)
- 4. Save key to flash drive and save it securely to a known location
- 5. Next
- 6. Activate Bitlocker

Protect data in transit

This includes data being sent over the internet.

- Consider using encrypted emails containing protected information
- Always use secure networks and websites when transmitting protected information.
- Look for the lock icon by the website URL



Protect data in transit Secure Connections

WiFi security, even at home

VPN whenever possible

Use known safe networks when possible

Isolate your work devices from household devices (use 2 routers if possible)

Backup, Backup, Backup

3-2-1 backup

3 copies of data

2 locations for data (office and home/cloud)

More than 1 different type of media

Ensure file/folder versioning is enabled anywhere files are saved Check backups once a quarter Setup failure notifications (at least emails) Practice disaster recovery!

Updates and disposal

Set auto-updates and check occasionally

When getting rid of equipment properly dispose by format/overwrite (or use a hammer).

Backup before destroying
